

Guest Motorcycle Waiver of Liability and Release Form

In consideration for being permitted to participate in American Legion Riders Chapter 58 events and activities:

THE UNDERSIGNED:

The receipt and sufficiency of which is acknowledged by signature hereon, freely, on behalf of myself, my heirs and estate, fully and finally waive, discharge, release and hold harmless the American Legion National, American Legion Post 58, American Legion Riders Chapter 58 and all executives, officers, directors, management officials, Road Captains, members or volunteers assisting in events thereof, from any and all liability, claims, demands, suits, whether known or unknown, fully, finally and forever by the signing of this waver.

Each of the Undersigned expressly acknowledges and agrees the activities of the event are dangerous and the hazards associated with riding motorcycles in these events involve the risk of serious injury and/or property damage.

Each of the The Undersigned Rider(s)certifies that he/she is in possession of a valid motorcycle license and motorcycle insurance and assumes all responsibility that such documents are current and recognized by the state in which the ride is being conducted.

Each of the Undersigned Rider(s) expressly acknowledges he/she is competent to operate a motorcycle in a safe manner, and the vehicle is in a safe operating condition and additionally agrees that he/she will be riding on public highways and is solely responsible to determine the speed and operational characteristics of that motorcycle while participating in the ride.

Each of the Undersigned certifies that he/she has no known physical or mental impairment that may affect his/her safety or the safety of the group. He/she understands that the choice of wearing a helmet or other protective gear is solely his/her own and assumes responsibility for his/her compliance with all state laws, including those regarding helmets.

Each of the Undersigned further expressly agrees the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as as is permitted by the state in which it is operated in and if any portion thereof is held invalid, it is agreed the balance shall, not withstanding, continue in full force and effect.

Each of the Undersigned certifies this document has been read, understands, and voluntarily signs this RELEASE AND WAIVER OF IABILITY AND INDEMNITY AGREEMENT, further agrees that he/she is not under the influence of any narcotic, alcohol, or other drug that may impair his/her understanding or judgment, and that no oral representations, statements, or inducements apart from the foregoing written agreement have been made.

It is also understood this Waiver and Release is in force for the duration of the ride, my participation with The American Legion Riders Chapter 58, and covers any and all activities.
